Tournament Rules (but not limited to)

- 1) All PA Fishing and Boating Laws & Regulations apply. Off limits will be announced prior to takeoff
- 2) All boats must be equipped with a factory installed live-well, operating kill-switch, current registration and boater's insurance with a policy minimum amount of \$200,000 in liability insurance.
- 3) All contestants under 18 years of age must be with an adult 21 or older
- 4) Limit of 5 fish per team. Minimum length will be 12"
- 5) Fish will be measured closed mouth and tail pinched or fanned
- 6) No courtesy measurements will be allowed during weigh-in
- 7) Artificial lures only, NO live bait will be allowed
- 8) All boats must be back at the ramp by the designated time. A late arrival will be assessed a penalty of 1 lbs. per min (DQ after 15min)
- 9) A team is single (1) angler or two (2) anglers per boat (entry fee is the same for both)
- 10) No leaving of boats while on the water to fish, except to retrieve a lure, restroom break, or for a boat emergency. No fishing is allowed by either angler while either angler is out of the boat. Members fishing docks while walking them will be disqualified. Member must contact official on water or on the shore in order to leave boat if not for lure retrieval, restroom break, or boat emergency.
- 11) A dead fish will incur a .50 pound deduction from total weight. NO culling of dead fish is permissible. A dead fish cannot be weighed in for lunker prize.
- 12) In the event of a tie, it will be broken by team's lunker. If a tie remains, payout will be split between the teams tied, and
- 13) Only one rod can be used at a time. No Trolling allowed.
- 14) Tournament Director will have final ruling over all issues or aspect pertaining to the tournament
